

Election Of The Board Of Directors

Notification was made in the Spring 2021 DFCU Newsletter that positions on the Board of Directors were up for election and that members interested in being considered as a candidate must send a resume to the nominating committee by May 14, 2021. The Nominating Committee, after reviewing the applications received, nominated Leon Brousseau, Tom Howard and Phil Maynard to serve three year terms.

Any other members wishing to be placed on the ballot must submit a petition. Petition forms are available at the DFCU Operations Center on 342 Tom Miller Rd., Plattsburgh, NY. Petitions must be signed by at least 170 DFCU members and returned by the close of business, July 30, 2021 to the same address.

Signatures (names) and account numbers on the petition will be checked to ensure validity. Members must be at least eighteen years of age to sign the petition and vote. Along with the signed petition, candidates must submit a signed letter agreeing to the nomination and stating that he/she will serve if elected. An election will not be conducted by ballot when there is only one nominee for each position to be filled. The ballot, if necessary, will be a mail ballot. There will be no nominations from the floor. Results of the election will be announced at the Annual Meeting.
